Re: Public comments on Design Review Permit 22-10, 600 Ramona Avenue, Sierra Madre

Dear City Council Chambers:

We are against the proposed design to build a two-story single-family residence at 600 Ramona Avenue because of its negative effect on amenity, specifically its over-towering and loss of privacy of nearby neighbors.

Our property at south of 600 Ramona Avenue. Because of the slope of the land, the second floor of the proposed building will be towering over our property. If the proposed design is approved, anyone behind a window in the south wall on the second floor would be able to see every movement we have in our backyard, or in our house near our glass patio doors. This would deprive us of our enjoyment of the privacy which was the reason that we purchased our house in Sierra Madre two decades ago. The new two-story building will also block our view of the San Gabriel Mountains.

We are happy to see our neighbor is planning improvement of their property, but for the above reasons we oppose the current plan. We hope that the applicant would opt for a one-story plan instead.
